Monarch Requirements

Applicants must meet all requirements as of January 31 of the current reign:

1. Applicants must be at least Twenty one (21) years of age.
2. Applicants will have been a continuous member from July 1st of the current reign and be members in good standing at date of application availability.
3. Applicant must have actually attended 75% of the meetings (combined or membership) during the current reign through January 31.
4. Applicants must have attended and participated in 75% of all ICAO events during the current reign through January 31.
5. Applicants must be able to prove they can afford in both time and finances the position they seek.

Applicants must also submit a letter along with the application to explain:

1. Your intent if elected as monarch
2. Qualifications for the position
3. Financial status or means to support for required travel
4. Other organizations you belong to or work with
5. Knowledge and experience with fundraising

Application fee of \$50 (cash, money order or certified check):

1. Fee must be submitted with application.
2. The application fee is refundable only if applicant does not become a candidate for monarch.
3. The \$50 fee of accepted candidates will provide a ticket to Coronation.

The applicants for candidacy will be reviewed and interviewed by the Screening Committee.
(See section 15.9 of the Policies and Procedures for the content of the screening interview.)

Official announcement of candidates will be within one week of all interviews. Each candidate will be informed privately of the Screening Committee's decision within 24 hours of that candidate's interview.

Candidates may NOT conduct any pre-campaigning before the official announcement of candidates. Pre-Campaigning will result in automatic disqualification from candidacy. Discussion with anyone other than the Board of Directors or past Monarchs prior to the official announcement of candidates is considered pre-campaigning.

Voting will take place one week prior to Coronation. Announcement of the election winner(s) will be made at Coronation. Candidates are required to attend as many functions as possible prior to Voting and Coronation.

Once cleared, the candidate is responsible for creating a monetarily profitable fundraiser before elections which must be approved by the Board. This fundraiser must raise at least \$100. Candidates will have a minimum of 30 days to campaign.

Deadlines and applicable dates are as follows:

1. Application deadline: Midnight Saturday, February 10, 2018
2. Screening Interviews: TBA (prior to February 28, 2019)
3. Candidate campaigning and fundraisers shall be between the date of the official announcement of candidates and March 22, 2018.
4. Public Voting: March 23, 2018 and/or March 24, 2018 - Locations To Be Announced
5. Coronation XI: March 31 2018
